This transfer petition has been filed by the petitioner-wife seeking transfer of Divorce Petition being O.P. No.1642 of 2019 filed by the respondent-husband before the Family Court at Chennai, Tamil Nadu to the Family Court at Kanpur, Uttar Pradesh.

On 08.08.2019, notice was issued by this Court and an interim order was passed staying further proceedings of the divorce petition.

We have heard learned counsel for the respondent and perused the prayer for transfer of the proceedings.

Mr. Shivankur Shukla, learned counsel appearing for the respondent-husband submits that he has no objection if the proceedings are transferred from the Family Court at Chennai to the Family Court at Kanpur.

Consequently, Divorce Petition being O.P. No.1642 of 2019, titled as "*Siddharth Kapahi v. Namrata Bhalla Kapahi*" filed by the respondent-husband before the Family Court at Chennai, Tamil Nadu is transferred to the Family Court at Kanpur, Uttar Pradesh.

The Family Court at Chennai is directed to transmit the entire record to the transferee court immediately.

The Registry is directed to send a copy of this Order immediately to both the Courts for compliance.

This transfer petition is allowed accordingly.
