This transfer petition has been filed by the petitioner-wife under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of HMA No. 1657 of 2019 titled as "Vinod vs. Anju", pending before the Court of Principal Judge, Family Court, Panipat, Haryana to the Principal Judge, Family Court, North West District at Rohini District Courts, Delhi.

As per office report, service of show-cause notice is complete by the postal tracking report. The respondent-husband has not entered appearance despite service.

Having considered the circumstances in their totality, we are of the view that in the interest of justice, transfer of the proceedings, as prayed for, is warranted.

Accordingly, this transfer petition is allowed and it is directed that HMA No. 1657 of 2019 titled as "Vinod vs. Anju", shall stand transferred from the Court of Principal Judge, Family Court, Panipat, Haryana to the Principal Judge, Family Court, North West District at Rohini District Courts, Delhi.

The parties shall be at liberty to apply before the transferee Court for appearing through the video conferencing mode.

The records of the case be transferred to the transferee Court forthwith.
