O R D E R

Heard the learned counsel for the petitioners and respondent. The contention which has been urged before us by Mr. Arjun Garg, learned counsel for the respondent is that the averment made in the paragraph 15 of the writ petition namely that the petitioners had made deposit of Rs.15,000/- towards the charges for affiliation on 09.03.2021 is not correct.

Mr. Amitesh Kumar, learned counsel for the petitioners explained this by pointing out that it was a bona fide mistake. More importantly it is pointed out that this is an institution which has recognition from the year 2014.

The prayer made is for quashing the order dated 08.09.2021 by which the affiliation granted for the year 2021-2022 has been withdrawn and to extend the time. Subject to terms which we shall indicate, we are of the view that the writ petition must be allowed.

In such circumstances, subject to the petitioners paying as costs sum of Rs. 1,00,000/- (one lakh) to the respondent within a period of one week from today.

The writ petition will be allowed as follows.

- (i) The cut off date shall extended.
- (ii) The impugned letter dated 08.09.2021 will stand quashed.
- (iii) Consequently, the respondent will give the renewal of affiliation to the petitioners for the year 2021-2022 .
- (iv) Petitioners are also permitted to participate in the counseling and admission process for admission of students in D.El.Ed. Course.

Pending application(s), if any, stand disposed of.
