O R D E RW.P.(C) NO. 1074/2023I.A. NO. 68254/2024

1. Through the instant application, the applicant prays that he may be permitted to surrender his Indian

Passport to the Indian High Commission, London, by sending it to the High Commission by registered post or by depositing it with the Indian High Commission without simultaneously being required to renounce his citizenship.

2. The respondent(s) have filed their objections to the application. In the course of the objections, in Paragraphs-12 and 17 thereof, it has been indicated that the Passport could be surrendered by the applicant.

3. Therefore, taking into consideration these aspects of the matter, the leave sought by the applicant to surrender his passport is permitted. All other aspects of the matter would remain subject to the result of this Writ Petition, which would be considered as and when the Writ Petition is taken up for hearing.

4. Application stands disposed of accordingly.

5. Objections to the said Writ Petition shall be filed within six weeks from today.
