O R D E R

On hearing learned counsel for the parties, we are of the view that the siblings of Master Ahren having moved to the US for further studies, very purpose of having sibling interaction really does not survive till they come on a vacation to India. Ahren has a dual citizenship of Thailand and USA. It not disputed before us by learned senior counsel for the petitioner, on instructions, that for higher education Ahren will move to US.

The prayer is only for relocation of Ahren to an appropriate High school till he attains the age to move for higher education to the US.

The aforesaid would also require that Ahren should keep coming to India to interact with siblings when they are in India and during that time interaction with the grand parents and the father

can also take place.

We give some time learned senior counsel for the parties to work out the details of the aforesaid and file the same before us.
