The petition is one seeking transfer in petition No. 752/2018 titled as "Mohit Sharma v. Smt Shweta Sharma" pending before the Family Court, Agra, Uttar Pradesh.

Heard the learned counsel for the parties. Though the learned counsel for the respondent prays that the matter be referred to mediation, the petitioner is apparently not amenable for the same. We see no reason why we should not allow the petition seeking transfer filed by the wife.
