This transfer petition has been filed by the petitioner-wife seeking transfer of Divorce Petition bearing M.C. No.3607 of 2020 titled "Gaurav Kumar Nanda vs. Nisha Nanda" pending before the Principal Judge, Family Court, Bengaluru to the Principal Judge, Family Court, District Hoshiarpur, Punjab.
