O R D E R

Heard learned counsel for the parties.

On 18th December, 2020 this Court while issuing
notice, passed the following order:-

"Mr. Kailash Vasudev, learned senior counsel,

Issue notice returnable within four weeks.

In the meanwhile, no coercive steps be taken against the petitioner subject to the Petitioner's cooperation in the investigation.

If required, the Petitioner would furnish and make available the electronic device to the Investigating Authority"

Having heard learned counsel for the parties and having regard to the Order dated 18th December, 2020, we direct that in the event of arrest of the petitioner, he shall be released on bail on such terms and conditions as may be imposed by the Trial Court.

The petitioner is, however, directed to cooperate with the investigation.

The Special Leave Petition is accordingly disposed of.
