O R D E R

1. This transfer petition has been filed by the petitioner-wife seeking transfer of petition filed by the respondent-husband being HMA Case No. 556 of 2020 titled as "*Pradeep Jairath Vs. Pinky Nain*" from the Family Court at Agra, Uttar Pradesh to the Court of Additional District Judge, Chandigarh.

2. On 18.12.2020, notice was issued by this Court and an interim order was passed staying further proceedings pending before the Family Court at Agra, Uttar Pradesh.

3. We have heard learned counsel for the petitioner. None has appeared on behalf of the respondent.

4. Considering the facts and circumstances on the record, we deem it appropriate to allow this transfer petition.

5. Consequently, HMA Case No. 556 of 2020 titled as "*Pradeep Jairath Vs. Pinky Nain*" pending in the Family Court at Agra, Uttar Pradesh is transferred to the Court of Additional District Judge, Chandigarh, who in turn

shall assign the matter to a Court of competent jurisdiction.

6. The Court at Agra, Uttar Pradesh is directed to immediately transmit the entire record to the transferee Court.

7. The Registry is directed to send a copy of this Order immediately to both the Courts for compliance.

8. This transfer petition is allowed accordingly.
