T.P.(CRL.) NO.384/2020:

The transfer petition is dismissed. However the court before which the Domestic Violence Act case is pending may dispense with the personal appearance of the petitioners and permit them to be represented through the husband-respondent.

Since one of the parties has to travel to Pune, the courts before which both cases are pending, if they are not the same court, shall fix the same date of hearing so that the parties need not travel twice a month.

The transfer petition is, accordingly, dismissed in the aforesaid terms.
