Having considered the submissions and averments made in the transfer petition, the Court is of the opinion that this is a fit case for transfer.

The transfer of HMA No.957/2018 titled as "Amandeep Singh Saluja Vs. Pawanjyot Kaur @ Ena", pending before the Principal Judge, Family Court, Saket, New Delhi is hereby directed to the Court of Principal Judge, Family Court, Haldwani, Nainital, Uttarakhand.

The transferee Court at Haldwani shall ensure that the date or dates of hearing are either the same or in close proximity (one or two days) before or after the dates of hearing in the other pending proceedings i.e. instituted by the wife i.e. (1) Case No.18 of 2020 - (application for maintenance under Section 125 Cr.P.C.) at Haldwani; (2) The Concerned Court of competent jurisdiction seized of the First Information Report as well as the final report in respect of allegations of commission of offences under Section 498A IPC etc.

The transferee Court and the court seized of Section 125 proceedings are hereby directed to conclude the said proceedings within a time frame i.e. not later than 31st December, 2021.

The Transfer Petition is disposed of in above terms.
