O R D E R

SLP(C) No. 1665-1666/2022

Service of notice is complete on respondent Nos. 2 and 3 but

no one has entered appearance on their behalf.

As per office report Ld. Counsel for respondent No.1 has not filed the counter affidavit.

Ld. Counsel for respondent No.1 submits that he will be adopting the counter affidavit filed by him in main matter i.e. SLP(C) No. 17369/2021 for the said respondent. Hence, the matter be processed for listing before the Hon'ble Court.

SLP(C) No. 5738/2022

Service of notice is complete on respondent Nos. 2 to 30 but no one has entered appearance on their behalf.

Four weeks time is granted to respondent No.1 to file the counter affidavit. After expiry of four weeks, the matter shall be processed for listing before the Hon'ble Court.

SLP(C) No. 2957/2022

Four weeks time is given to respondent Nos. 1 and 2 to file the counter affidavit.

Ld. Counsel for Mr. Vatsalya Vigya (Caveator) submits that he will be adopting the counter affidavit filed by him in main matter i.e. SLP(C) No. 17369/2021 for the said respondent.

In respect of other respondents, in terms of Hon'ble Court's Order dated 25.3.2022, Ld. Counsel for petitioners has failed to file spare copies for issuance of notice. However, one week's time is given to Ld. Counsel for petitioners to file the same. If the same is filed, notice be issued and list the matter again on 16.3.2022.

In case of default whereof, list the matter before the Hon'ble Judge in Chambers for further directions.

SLP(C) No. 4737-4738/2022

Learned counsel for the petitioners shall within a period of two weeks file the fresh particulars respondent No.4 in SLP(C) Nos. 4737/2022 and in respect of Respondent Nos. 22 and 33 in SLP(C) Nos. 4738/2022 and he shall also take fresh steps for the service of notice to them within the same period.
