O R D E R

This transfer petition has been filed by the petitioner-wife under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of HMOP No.22 of 2020 titled as "Rowthu Ashok Babu vs. Rowthu @ Arella Mounika", pending before the Senior Civil Judge, Addanki, Prakasham District, Andhra Pradesh to an appropriate Court/Family Court, Warangal District, Telangana.

Heard learned counsel for the parties.

Having considered the circumstances in their totality, we are of the view that in the interest of justice, transfer of the proceedings, as prayed for, is warranted.
