The prayer in the petition, inter-alia, is as follows:-

(i) Transfer the Divorce Petition bearing H.M.O.P. No.745 of 2020 filed & pending before the Ld. Family Court at Chennai, titled as Mr. S. Jithender Reddy S/o. Sama Linga Reddy vs. Ms. Parinaya @ Greeshma B. D/o Baddam Anil Reddy u/s 13 of the Hindu Marriage Act, 1955 to the competent Court i.e. Ld. Civil Judge Senior Division Pandharkawada (Kelapur), Dist. Yavatmal, Maharashtra.
