ORDER

- 1 This transfer petition has been filed by the petitioner for transfer of the proceedings in HMA No 278 of 2015 titled “Anil Kumar Garg vs Shanu Agarwal” from the Court of the Principal Judge, Family Court, District Pathankot, Punjab to the Court of the Principal Judge, Family Court at Katni, Madhya Pradesh.
- 2 Heard counsel appearing on behalf of the petitioner.
- 3 The office report indicates that the service of notice is complete but no one has entered appearance on behalf of the sole respondent.
- 4 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the transfer petition and direct that HMA No 278 of 2015 titled “Anil Kumar Garg vs Shanu Agarwal” be transferred from the Court of the Principal Judge, Family Court, District Pathankot, Punjab to the Court of the Principal Judge, Family Court at Katni, Madhya Pradesh.

- 5 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.
- 6 After transfer of the petition, the transferee Court is requested to make all endeavour for an expeditious disposal of the petition without unnecessary adjournments.
