UPON hearing the counsel the Court made the following
O R D E R

Issue notice, returnable within four weeks.

Tag with the SLP (C) No. 16254/2018 titled as" Solapur Municipal Corporation vs. Kamgar Kranti Union and Ors."

The operation of the impugned order would remain stayed subject to:

- (i) the petitioner depositing Rs. 1 crore with the High Court within four weeks from today; and
- (ii) the petitioner paying shortfall towards salaries and pensions of the employees/retirees of Solapur Transport by 15th of the next month.

This direction would be effective for the salaries payable for the month of November 2021 and onwards. This means that shortfalls towards salaries and pensions for the month of November 2021 would be paid by the petitioner to the Solapur Transport by the 15th of December 2021.

Direction (ii) above will continue to apply for the subsequent months until modified by this Court.

In case of any default, the interim order passed above would automatically cease to apply and the directions issued by the High Court would become applicable.

The deposit of Rs. 1 crore would be disbursed to the employees/retirees of Solapur Transport in terms of the directions issued in the order dated 12.11.2021 passed in SLP (C) No. 16254/2018.
