O R D E R

State of Maharashtra, in spite of repeated opportunities, has not filed the counter affidavit/reply in terms of order dated 13.12.2021. A request is again made by State of Maharashtra for six weeks' time to file the counter affidavit/reply in terms of the said order.

While granting time as prayed, we direct that the State of Maharashtra will make an *ad hoc* payment of Rs.10,00,000/- (Rupees Ten Lakhs only) to the petitioner - Solapur Municipal Corporation, which amount will be paid towards arrears payable to the pensioners/retired employees of the said Corporation on *pro rata* basis.

It will be open to the State of Maharashtra to ascertain the dues payable by the petitioner - Solapur Municipal Corporation to the serving and retired employees.
