UPON hearing the counsel, the Court made the following
O R D E R

Learned counsel appearing for respondent no.4 - State of Maharashtra once again prays for adjournment. He also apologizes for the default in not making the *ad hoc* payment of Rs.10,00,000/- (Rupees ten lakhs only) as was directed by the last order dated 20.02.2023. While we grant the adjournment, we direct respondent no.4 - State of Maharashtra to deposit Rs.10,00,000/- (Rupees ten lakhs only) as directed by the earlier order dated 20.02.2023 and another amount of Rs.20,00,000/- (Rupees twenty lakhs only). The said payment of Rs.30,00,000/- (Rupees thirty lakhs only) must be made within a period of six weeks from today. In case of default respondent no. 4 will be burdened with interest from the date of default and also costs.

Once the payment/amount is received, the amount will be paid in terms of the order dated 20.02.2023.

Learned Senior Advocate appearing for the Union of India has pointed out that the arrears of actual wages amounting to Rs.4.5 crores are to be paid. This is an aspect which respondent no.4 - State of Maharashtra must keep in consideration.
