

pending before the Principal Judge, Family Court, Saket, Delhi to Family Court in Ahmedabad, Gujarat and (iv) Cr1.Case No.1668/2020 titled "State v. Abhishek Sharma & Ors." pending before the Chief Metropolitan Magistrate, South-West Dwarka, Delhi to the Chief Metropolitan Magistrate, Ahmedabad, Gujarat.

(3) During the pendency of these transfer petitions, pursuant to this court's order dated 6th May, 2022, both the parties amicably settled the disputes between them by entering into Memorandum of Understanding dated 11th May, 2022 whereby the entire amount of Rs.25,00,000/- (Rupees twenty-five lakhs) by way of two Demand Drafts (Rs.10,00,000/- + Rs.15,00,000/-) in the name of daughter-Manushi Sharma have been received by the petitioner-wife in full and final settlement of all her claims. As per the Memorandum of Understanding, custody of the daughter-Manushi Sharma will remain with the petitioner; both the parties have agreed to withdraw the cases filed by them against each other; and will also cooperate with each other for smooth transfer of their individual belongings.

(4) The parties have now filed a joint application (I.A.No.73735 of 2022) under Article 142 of the Constitution of India for seeking dissolution of their marriage by granting a decree of divorce by mutual consent.

(5) Having regard to the amicable settlement arrived at between the parties, the marriage between the petitioner-Preeti Sharma and the respondent-Abhishek Sharma (husband)

stands dissolved by way of decree of divorce by mutual consent. The Memorandum of Understanding dated 11th May, 2022 shall form part of this Order.

(6) In view of above, the proceedings in Divorce Petition being HMA Petition No.389/2019 titled "Abhishek Sharma v. Preeti Sharma" pending before the Principal Judge, Family Court, Saket, Delhi is dismissed as withdrawn and FIR No.13/2019 registered at P.S.CWC, Nanak Pura, New Delhi is hereby quashed.

(7) The joint application (I.A.No.73735 of 2022) is accordingly allowed and the transfer petitions are disposed of.
