O R D E R

It is brought to our notice that in Writ Petition (Cr1.) No. 75/2020 order has been passed by this Court dated 12.05.2022 consolidating the FIRs instituted in 12 different States and further action has to be taken in each of the State pursuant thereto.

The investors are before this Court. Their complaint is that whatever the sale proceeds come forward from the assets of the defaulters, at least, the investors should be made entitled to claim pro rata in reference to the investments made by them.
