O R D E R

We are informed across the bar that the respondent No.1-Company has properties in the States of Madhya Pradesh, Haryana and Telangana. As far as States of Haryana and Madhya Pradesh are concerned, the description of the properties of the Company which are attached, is already placed on record.

Learned counsel appearing for the State of Telangana states that time may be granted to place the details of the properties and orders of attachment, if any, on record. We accordingly, grant time of three weeks to the State of Telangana to file an affidavit putting on record necessary details.

Learned counsel appearing for other States also to take instruction whether the orders of attachment are in force and whether there are any other proceedings filed to challenge the orders of attachment

One of the options which we will have to consider is of directing auction of the attached properties.

To enable the States to respond, we direct that the petition shall be listed on 02nd April, 2024(NMD) at 2.00 P.M.

In the meanwhile, notice be issued to the respondents who are not represented before the Court.
