O R D E R

It is stated by Mr. Ravi Prakash Mehrotra, learned counsel appearing on behalf of the appellants, that the appellants have already submitted Detailed Project Report (DPR) to the National Green Tribunal (NGT). As per the order of the NGT, copies thereof are also provided to the learned counsel for the parties. The NGT has now fixed the matter on 22.01.2018 when the DPR submitted by the appellant shall be considered and appropriate order shall be passed thereon.

In the present appeal we are concerned with the order dated 09.08.2017 as per which performance guarantee of Rs.1 crore submitted by the appellant has been forfeited and it is further directed that the amount be utilized with regard to grant of compensation to the victims of environment.

After hearing the learned counsel for the parties, we modify the aforesaid order only to the extent that the amount may be

utilized for procuring the machinery etc. which is required in furtherance of environment and in what manner it should be utilized in respect of the project in question the NGT shall decide.

The appeal is disposed of accordingly.
