O R D E R

In terms of the Settlement arrived at between the parties, today, the alleged contemnor/respondent has handed over to the petitioner two Demand Drafts, one in favour of the petitioner/wife for a sum of Rs.5,00,000/- (Rupees Five Lacs) and the other in favour of the daughter for a sum of Rs.2,00,000/- (Rupees Two Lacs).

2. The order of this Court for payment of money is dated 05.05.2016; however, the actual payment has been made only in 2018.

3. Though, the learned counsel for the alleged contemnor tendered apology for the delay, we are of the view that in the interest of justice the petitioner should also be compensated for the period of delay in paying the amount and by costs of these proceedings. Therefore, the respondent is directed to pay a further sum of Rs.1,00,000/- (Rupees One Lac), within four weeks, by way of Demand Draft drawn in the name of the petitioner/wife. The Demand Draft, as above, shall be handed over to the learned counsel appearing for the petitioner.

4. In view of the above, the contempt petition is disposed of.

5. Pending applications, if any, shall stand disposed of.
