**UPON hearing the counsel the Court made the following
 O R D E R**

1. Mr. Basavaprabhu S. Patil, learned senior counsel appearing for Karnataka Industrial Areas Development Board¹, has placed before us the Karnataka Industrial Area Development (Amendment) Act, 2022.
2. According to him, in terms of the Amendment Act, various provisions² of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 shall be deemed to form part of the

Karnataka Industrial Areas Development Act, 1966.
