1. We have heard learned counsel for the parties.

3. Having regard to the grounds on which transfer has been prayed for, we are satisfied that it is a fit case for transfer. Since both the parties are agreeable for the transfer of case bearing CC No. 27758 of 2018 titled as "Dr. Harramb Mittal Vs. Sanjay Goyal" pending before the 13th Additional Chief Metropolitan Magistrate at Bangalore, Karnataka AND case bearing CC No. 597 of 2018
