Learned counsel for the petitioner states that FIR No.321/2021 registered at Police Station Rai, District Sonipat, Haryana was investigated by police station Kidwai Nagar, Kanpur, Uttar Pradesh where it was renumbered as FIR No.140/2021.

Mr. Rana Mukharjee, learned senior advocate appearing for the State of Uttar Pradesh, states that Closure Report dated 13.09.2021 has been filed in FIR No.140/2021 and the petitioner has filed a protest petition, which is pending.

Ms. Bina Madhavan, learned counsel appearing for the State of Telangana, states that the petitioner has not joined investigation in FIR No.658/2021 dated 10.06.2021 registered at police station Madbapur, District Cyberabad, Telangana.
