O R D E R

This application has been filed by the petitioner for recalling the order dated 19.07.2019.

By the order dated 19.07.2019, the SLP(C)No. 16053 of 2019 was came to be dismissed on the ground that there was no good ground warranting interference with the impugned order dated 25.04.2019.

We have heard Mr. Sanjay R. Hegde, learned senior counsel appearing on behalf of the petitioner as well as learned counsel appearing on behalf of the State of U.P.

Learned senior counsel appearing on behalf of the petitioner has submitted that in other matters of the same issue i.e. Civil

Appeal No. 9647 of 2013 @ SLP(C)No. 4309 of 2013 viz. Anju Kushwaha vs. The Regional Inspectress of Girls School and Civil Appeal No. 9648 of 2013 @ SLP(C)No.22233 of 2013 viz. R.M.P. Singh vs. Comm. Of MGT. Of Patel Memorial Inter, notice ordered/leave has been granted. Learned senior counsel therefore prays to recall the order dated 19.07.2019.

Learned counsel for the State of Uttar Pradesh has submitted that the present SLP(C)No. 16053 of 2019 stands on different footing from the other case(s).

Merit of the contentions to be considered only if the SLP(C)No. 16053 is restored to its original number.

Considering the submissions of the learned senior counsel for the petitioner and the averments made in the application, the order dated 19.07.2019 is ordered to be recalled and restored to its original number and tag with Civil Appeal No. 9647 of 2013 (@ SLP(C)No. 4309 of 2013) and Civil Appeal No. 9648 of 2013 (@ SLP(C)No. 22233 of 2013).

M.A. is disposed of accordingly.
