This is a transfer petition at the instance of the petitioner-wife seeking transfer of Case No.1468 of 2016, titled Anil Joshi vs. Smt.Haritima Joshi, pending before the Court of Principal Judge, Family Court, Ghaziabad, Uttar Pradesh to the Family Court, Dehradun, Uttarakhand.
