- 1 This transfer petition has been filed by the petitioner-wife for transfer of Petition No 577 of 2019 titled "Sandip Kumar Modanval vs Usha Modanval" from the Court of the Chief Judge, Family Court, Mirzapur, Uttar Pradesh to the Court of the Principal Judge, Family Court, Ahmedabad, Gujarat.
- 2 We have heard counsel appearing on behalf of the petitioner.
- 3 The office report indicates that service is complete, but none has entered appearance on behalf of the sole respondent.
- 4 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the transfer petition and direct that Petition No 577 of 2019 titled "Sandip Kumar Modanval vs Usha Modanval" be transferred from the Court of the Chief Judge, Family Court, Mirzapur, Uttar Pradesh to the Court of the Principal Judge, Family Court, Ahmedabad, Gujarat.

- 5 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.
- 6 After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
- 7 Pending application(s), if any, stands disposed of.
