We are satisfied, that the proceedings in Petition No.320 of 2014, titled as Smt.Sangeeta Jaiswal W/o Ajay Jaiswal versus Mr.Ajay Jaiswal S/o Late Shri Mahesh Jaiswal, pending before the Court of Family Judge at Jhansi, Uttar Pradesh, should also be transferred to the Family Court at Bhopal, Madhya Pradesh, in view of the order passed by this Court on 12.07.2016, wherein a pending dispute between the same parties was transferred to the Family Court at Bhopal.
