It was observed in said paragraph and more particularly in sub paras (f) to (j) that the reasons for non-appointment of all persons who were part of the list of 12091 candidates were available on record since October, 2016 and yet no grievance was made till the matter was disposed of in July 2017.

In these Review Petitions, nothing has been placed on record to show whether any grievance was made during said period.

We have gone through the contents of the Review Petitions and do not find any error apparent on record to justify interference.

These Review Petitions are, therefore, dismissed.
