O R D E R

1. Leave granted.
2. Heard the learned counsels for the parties and perused the relevant material.
3. In the Special Leave Petition (C) No.39384 of 2013, the challenge by the Karnataka Neeravari Nigam Limited was in respect of an order of the High Court by which compensation of Rs.3,00,000/- per acre was awarded by the High Court. The land acquired in the said case was by means of the same

notification as in the present case. By the orders under challenge in the present appeals, compensation for the land covered by the same notification had been reduced to Rs.2,25,000/- per acre.

4. Special Leave Petition (C) No.39384 of 2013 has been dismissed by this Court on 16.12.2013 and consequently the order of the High Court awarding compensation at the rate of Rs.3,00,000/- per acre has been confirmed by this Court. In the above facts, all the appeals shall stand answered and disposed of holding that the land owners in the present appeals would also be entitled to a compensation at the same rate i.e. Rs.3,00,000/- per acre along with all statutory benefits.

5. The appeals are disposed of in the above terms. The order of the High Court is modified to the above extent.
