ORDER

- 1 The petitioner instituted a writ petition before the High Court of Delhi in order to challenge an order passed by Mr R S Virk, former District Judge on 24 April 2019.
- 2 The correct course of action for the petitioner would have been to file an application in Civil Appeal No 13301 of 2015 pertaining to the PACL Group of Companies and to raise all objections to the order passed by Mr R S Virk, who has been appointed in pursuance of the directions of this Court.
- 3 Counsel appearing on behalf of the petitioner states that the writ petition has already been withdrawn before the High Court.
- 4 We clarify that the petitioner would be at liberty to pursue appropriate proceedings by filing an application in Civil Appeal No 13301 of 2015.
- 5 No orders are required to be passed for the transfer of the proceedings. The Transfer Petition is disposed of.
