O R D E R

Leave granted.

The appellant seeks bail in connection with FIR No.0603/2024 dated 24.07.2024 for the offences punishable under Sections 420, 406, 403, 404, 120B of the Indian Penal Code, 1860 and Section 66 (C) of the IT Act. The regular bail granted to the appellant by the High Court vide order dated 20.12.2024 was cancelled by the High Court vide the impugned order for the non-compliance of the

condition imposed on the co-accused Sadhvi Laxmi Das regarding the payment of a sum of Rs.90,00,000/-. On the basis of the said undertaking, the High Court had enlarged the appellant on regular bail.

Expressing his inability to comply with the conditions imposed, the appellant has approached this Court.

It is not in dispute that the appellant is unable to comply with the conditions himself.

Furthermore, the appellant has only sought bail, which has been cancelled by the High Court for non-compliance of the conditions of an earlier order imposed.

In such view of the matter, we are inclined to set aside the impugned order and confirm the regular bail granted to the appellant by the High Court vide the order dated 20.12.2024, particularly, in view of the fact that the charge sheet has already been filed.

Accordingly, the impugned order is set aside

and the appellant is granted bail, on the terms and conditions to the satisfaction of the Trial Court.

The appeal stands allowed accordingly.

Pending applications, if any, shall stand disposed of.
