O R D E R

1. Learned counsel agreed that the parties' *inter se* dispute have been settled amicably under the aegis of the Supreme Court Mediation Centre. The Settlement Agreement was executed by the parties on 13th May 2022; which is part of the record.

2. In terms of the settlement, the respondent had paid a sum of Rs.4,00,000/- (Rupees four lakhs only) on 13th May 2022 and has deposited a sum of Rs.6,00,000/- (Rupees six lakhs only) thereafter.

3. Learned counsel for the parties submit that parties have resolved all their disputes, and have no further grievances with each other. They consequently seek this Court's intervention in dissolving their marriage in exercise of its power under Article 142 of the Constitution of India. It is also requested that proceedings (Marriage Case No.198 of 2019) initiated by the husband in the Family Court, Guna, Madhya Pradesh may also be dropped/quashed.

4. The Settlement Agreement is hereby taken on record and shall form part of the present order. The Court is satisfied that the parties have entered into settlement of their own volition - as is supported by the affidavits executed by them in this regard.

5. Since the sum of Rs.10,00,000/- has been made over to the petitioner through counsel in compliance with the terms of the Settlement Agreement, accordingly it is hereby directed that:

(a) Marriage Case No.198 of 2019 pending before the Family Court, Guna, (Madhya Pradesh) shall stand withdrawn to this Court and is accordingly quashed/dismissed.

(b) A decree of divorce dissolving the marriage between the petitioner and respondent is hereby granted.

6. The transfer petition and pending applications stand disposed of in the above terms.
