O R D E R

This is a transfer petition at the instance of the petitioner-wife seeking transfer of O.P.No.D-30 of 2016, titled as Mr.Kaushik Banerjee vs. Mrs.Anindita Kaushik Banerjee, pending adjudication before the Family Court at Bandra, Mumbai, in the State of Maharashtra, to the Family Court, Miyapur, Ranga Reddy District at Hyderabad, in the State of Telangana.

The petitioner has sought transfer of the case mainly on the ground of financial difficulty and her inability to travel from Hyderabad to Bandra, which is at a distance of more than 700 km, to attend the proceedings of the case filed by the respondent.

Heard learned counsel for the parties and perused the record.

In view of the hardships which will be faced by the petitioner in contesting the case at Bandra, Mumbai, and taking into consideration the fact that the petitioner-wife has already filed a petition for maintenance in the Family Court, Miyapur, Ranga Reddy District at Greater Hyderabad, in the State of

Telangana, we deem it proper to allow the transfer petition and direct transfer of O.P.No.D-30 of 2016, titled as Mr.Kaushik Banerjee vs. Mrs.Anindita Kaushik Banerjee, pending adjudication before the Family Court at Bandra, Mumbai, in the State of Maharashtra, to the Family Court, Miyapur, Ranga Reddy District at Hyderabad, in the State of Telangana, along with all records for its adjudication. Ordered accordingly.

After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
