IA No. 3171/2022 - PERMISSION FOR WITHDRAWAL OF AMOUNT

The matter has been put on the Registry note on the request of the counsel for the petitioner for withdrawal of the money lying in the FDRs. The order was already passed by this Court on 02.03.2021 directing that on the elder daughter attaining majority on 21.04.2021, Rs.2.5 lakh be released to her. It appears the amount was lying in FDR and the FDR has already matured on 24.05.2018.

We direct that the FDR be renewed for a minimum period as would entitle the parties to the interest from the date of expiry of the FDR till the next date of maturity. On the amount being realized along with accrued interest, the amount be disbursed in terms of the order dated 02.03.2021 i.e Rs.2.5 to the daughter-Anushka Malik who has attained maturity along with the proportionate interest and Rs.2.5 lakh to the mother

for the benefit of the younger child along with accrued interest.

In order to facilitate, the original FDR be released to the parties to take necessary steps with the Bank.
