Learned senior counsel for the petitioners submits that most of the claims of the debenture holders have been settled but some more debenture holders have raised claims and the petitioners are willing to settle the claims of all of them. In order to secure the amount, he submits that the petitioners will deposit a sum of Rs.25 lakh before the High Court within ten days.

We permit the petitioner to do so and the amount be kept in an FDR initially for 91 days to be kept renewed so that it earns some interest and as and when the claims are determined, the amounts can be disbursed out of the same.

In the meantime, the petitioners be not arrested subject to the compliance of deposit in the aforesaid period of time.
