O R D E R

The directions issued by this Court in its order dated 15.12.2021 have been complied with and appropriate reports have been placed on record.

The directions issued in the subsequent order dated 29.03.2022 gave opportunity to the learned counsel appearing for the accused to place on record such mitigating circumstances, which may be relevant at the stage of consideration of punishment, if any.

In pursuance of the directions, Ms. C.P. Shruti, was afforded the opportunity to have an interaction with the appellant.

Mr. Siddharth Aggarwal, learned advocate for the accused submits that the appropriate material gathered pursuant to interaction with Ms. Shruti shall be placed on record within a week.
