UPON hearing the counsel, the Court made the following
O R D E R

SLP(C) No. 20228/2021, SLP(C) No. 20308/2021 and
SLP(C) No. 20984/2021

Respondent Nos.1 and 12 are granted four weeks' time, as last opportunity, for filing counter affidavit.

Service is complete on respondent Nos.2 to 10.

Respondent No.13-in-person has filed Memo of Appearance, Affidavit of Opposition and Application for permission to appear and argue in person in respect of respondent Nos.1-10 and 13, however, 'No Objection Certificate' has not been obtained from respondent No.1 except for respondent No.1 in SLP(C) No. 20984/2021. Interaction has been done. Four weeks' time, as last opportunity, is granted for filing Memo of Appearance and reply as well as power of attorney on behalf of respondent No.3 in SLP(C) No. 20228/2021.

Ld. Counsel for the petitioner is granted two weeks' time, as last opportunity, to take fresh steps in respect of the unserved respondent No.3 in SLP(C) No. 20228/2021.

Ld. Counsel for respondent No.4 submits that he has filed vakalatnama on record by seeking "No Objection Certificate"

from the previous counsel. Registry to verify the same and update the records.

Service is complete on the remaining respondents, but none has entered appearance.

SLP(C) No. 20344/2021

The office report indicates that respondent No.4 has filed counter affidavit without obtaining "No Objection Certificate" from the respondent No.11-in-person. However, Ld. Counsel for respondent No.4 submits that he has been appointed as legal aid counsel of respondent No.4.

Respondent No.10 is granted four weeks' time, as last opportunity, for filing counter affidavit.

Respondent No.11-in-person has filed Memo of Appearance, Affidavit of Opposition and Application for permission to appear and argue in person in respect of respondent Nos.1-3 and 5-8. Four weeks' time, as last opportunity, is granted for filing Memo of Appearance and reply.

Ld. Counsel for the petitioner is granted one week's time, as last opportunity, to file proof of service of pleadings upon the respondent (Gramin Bank) in all the matters. Counter affidavit be filed within four weeks thereafter.

Service is complete on the remaining respondents, but none has entered appearance.
