O R D E R**

IA NOS 14869/2022 & 14870/2022 IN WP (C) NO 1377/2021

- 1 Ms Sharukh Alam, learned counsel appearing on behalf of the applicant states that the order dated 10 January 2022 passed by this Court, though reported widely, formally remained to be served on the Superintendent of Police. A notice under Section 41A of the Code of Criminal Procedure, 1973 dated 20 January 2022 was issued in the name of the mother of the applicant (possibly, according to counsel, because the permanent address of the applicant is of the house which stands in the name of his mother) requiring the attendance of the applicant today.
- 2 Since the applicant has been protected by the previous order of this Court dated 10 January 2022, no further steps shall be taken in pursuance of the notice under Section 41A pending further orders.
- 3 Mr Shuvodeep Roy, learned counsel appearing on behalf of the State of Tripura shall communicate both a copy of the present order and the previous order dated 10 January 2022 to the Superintendent of Police to ensure strict compliance and obviate harassment.
- 4 The Interlocutory Applications are accordingly disposed of.
