O R D E R

The present Special Leave Petition has been preferred against refusal of anticipatory bail to the petitioners in connection with FIR No.358/2019 for the offence under Sections 420, 406, 120-B of the Indian Penal Code (IPC).

By an earlier order passed by this Court on 05.02.2020, the petitioners have been protected from arrest.

It is reported that though initially the petitioners did not cooperate with the investigation in the year 2020, however, thereafter, they have cooperated in the investigation. Under the circumstances and in the facts and circumstances of the case and subject to cooperating with the investigation and to remain present before the Investigating Agency/Officer as and when required and/or called, it is directed that in case of arrest of petitioners in connection with the FIR in question, the petitioners be released on bail on the terms and conditions that may be determined by the learned Trial Court.

The Special Leave Petition stands disposed of, in terms of the above.
