O R D E R

Heard the learned counsel appearing for the  
petitioners.

Delay condoned.

In this group of matters, all the respondents are  
work charged employees. A Division Bench of the Madhya  
Pradesh High Court decided Writ Appeal No.966 of 2009  
which has attained finality. In the said appeal, the  
High Court held as follows:

"7. The complete reading of these Rules indicates  
that a contingency paid employee attaining the  
permanent status and a work charged employee  
attaining the permanent status are treated to be  
similar in all respects for the purpose of  
granting them pension and revision of pay scales  
under the M.P. Work Charged and Contingency Paid  
Employees Revision of Pay Rules, 1990 and under  
the M.P. (Work Charged and Contingency Paid  
Employees) Pension Rules, 1979."

As the view taken by the High Court has attained  
finality and as most of the respondents were employed in  
late 80s or early 90s, we do not find any error committed

by the High Court when a direction was issued to give benefit to work charged employees in terms of the aforesaid decision. Hence, there is no merit in the Special Leave Petitions and the same are accordingly dismissed.

Pending applications also stand disposed of.
