O R D E R

Heard the learned counsel for the parties and perused the petition papers.

This Court, at the first instance, while directing notice to the respondents on 04.02.2020, taking into consideration all aspects of the matter, had granted interim protection against arrest of the petitioners. Though, on the last date it was

indicated that the petitioners are yet to appear before the Investigating Officer, it is pointed out that the petitioners have appeared thereafter on 19.01.2023 and have recorded their statements. In any event, if any further necessity is there for the petitioners to appear for the purpose of investigation, they shall diligently appear as and when summoned by the Investigating Officer.

Subject to the above, the Order dated 04.02.2020 is made absolute. The interim protection granted to the petitioners shall enure to the benefit of the petitioners till the completion of the process. However, liberty is reserved to the respondents to bring it to the notice of the trial Court if there is any violation of the conditions imposed by the Trial Court upon the petitioners.

Petition is accordingly disposed of.
