UPON hearing the counsel the Court made the following  
O R D E R

1. Applications seeking exemption from filing certified copy of the impugned order as also for seeking exemption from filing official translation of the Annexures are allowed.
2. Heard Mr. Ranjit Kumar, learned Senior counsel appearing for the petitioners – State of Bihar in all these matters.
3. The main objection of learned Senior counsel appearing for the petitioner – State of Bihar is with respect to the observations made by the High Court in the bail orders to the effect that the sample was taken only from one bottle and no sample was taken from the other sealed bottles. It is submitted that such an observation may adversely affect the cases that are still pending trial.
4. We are in agreement with the aforesaid argument advanced by the learned Senior counsel.
5. Accordingly, it is clarified that any observations made in the impugned orders passed by the High Court on the above lines will not come in the way of the trial court to determine the issues raised. The cases shall be dealt with purely on their own merits and in accordance with law.
6. Taking into consideration the fact that bail has already been granted to the respondents – herein, we do not propose to interfere with the impugned orders passed by the High Court.
7. The Special Leave Petitions are, accordingly, dismissed.
