O R D E R

Mr.C.A.Sundram, learned senior counsel for the appellant has assailed the impugned judgment in which the impugned judgment itself gave a benefit of 50% waiver of court fee. We are not inclined to admit this matter inasmuch as a discretion has rightly been exercised by the Appellate Tribunal.

However, Mr. C.A.Sundram points out that what is appealed against is a common order, and 11 appeals are filed because there was 11 different parties. Therefore, he has made a fervent plea before us that at least one court fee should be paid, given the fact that there is one common judgment. According to us, on the facts of the present case, given the fact that the appellant has earlier successfully assailed several

other orders, we allow this indulgence limited to this case. The appellant will, therefore, pay a court fee of Rs. 1,00,000/- within a period of two weeks from today.

The appeal is disposed of accordingly.
