O R D E R

1. Leave granted.
2. The appellant Haidar Ali @ Sonu Shah is facing trial for offences punishable under Sections 379, 420, 467, 468, 471, 120-B and 413/34 of IPC. He has been in custody for more than one year ten months. The High Court by order dated 14.07.2016 in M.Cr.C. Nos. 3650 of 2016 and 3652 of 2016 and vide order dated 02.08.2016 in M.Cr.C. No. 3642 of 2016 rejected

the bail applications. After investigation, chargesheets have been filed before the trial court. It is also evident that co-accused have been granted bail.

3. Having heard learned counsel for the parties, we are of the view that it is just and proper to release the appellant on bail. Therefore, we order him to be released on bail on execution of his personal bond in sum of Rs. 25,000/- with one surety in the like sum separately in each of the cases to the satisfaction of the trial judge.

4. The impugned orders of the High Court are set aside and the appeals are accordingly allowed.
