O R D E R

There is delay of more than 250 days in each case in filing review petition.

In the instant case the acquisition pertained to 21.82 acres of land and the Land Acquisition Collector had awarded compensation at the rate of Rs.8 lakh per acre with other benefits. This compensation was raised by the Reference Court and finally by the High Court

where the value was assessed at Rs.18.8 lakhs per acre along with severance charges and statutory benefits. The acquisition was initiated in the year 2008 in Haryana and the value of the land was found to be correctly assessed by the High Court.

In the circumstances the special leave petitions were dismissed, which order is the subject matter of these review petitions.

We do not find any error apparent on the face of record. These review petitions are dismissed, both on the ground of delay as well as on merits.
