UPON hearing the counsel the Court made the following
O R D E R

SLP(Cr1.)No.10003/2021

1. Heard learned Senior counsel appearing on behalf of the parties and carefully perused the material placed on record.
2. Learned Senior counsel appearing on behalf of the respondent - State, on instructions, states that the investigation is still going on and the petitioner is likely to be asked to join further investigation.
3. This Court vide order dated 12.01.2022 while granting interim bail to the petitioner - K.T. Rajenthrahalaji imposed upon him the following conditions:

"1. The petitioner shall not leave the place of the jurisdictional police station where the alleged offences are registered.

2. The petitioner shall surrender his passport to the concerned Magistrate forthwith.

3. The petitioner shall participate in the investigation and co-operate with the Investigating Agency."

4. Such other terms and conditions which may be imposed

by the trial court."

4. Learned Senior counsel appearing on behalf of the petitioner prays that condition No.1 imposed upon the petitioner vide order dated 12.01.2022 may be relaxed as his client has to travel within the State of Tamil Nadu.

5. In view of the prayer made on behalf of the petitioner, the above-mentioned condition No.1 imposed upon the petitioner is modified to the extent that he is ordered to travel within the State of Tamil Nadu after informing the Investigating Officer subject to the condition that he shall not make any direct or indirect attempt to influence the witnesses.

6. The petitioner shall be at liberty to apply for renewal of his passport through the Investigating Officer. The application, if any, made by the petitioner for renewal of his passport may be forwarded by the learned Magistrate before whom the passport has been deposited. The passport, after its renewal, shall again stand deposited with the learned Magistrate.

7. I.A. Nos.85135/2022 and 36392/2022 stand disposed of accordingly.

8. List the Special Leave Petitions on 31.10.2022.

9. Interim order to continue until further orders.
