A substantial question of law arises in these appeals as to whether considering the provisions of Section 14 of the National Green Tribunal Act, 2010 conferring jurisdiction on the Tribunal over all civil cases relating to the environment, the Tribunal could have passed the impugned orders relating to banning of sand/bajri

mining.

We admit these appeals on this question. We may formulate further substantial questions of law after hearing learned counsel for the parties after notice.
